Notice of Acquisition of Shares of midori co., ltd.

Amvis Holdings, Inc. (Chuo-ku, Tokyo; Representative Director and CEO: Keiichi Shibahara, hereinafter, the “Company”) announces that on February 6, 2025, it acquired 100% of the outstanding shares of midori co., ltd. (hereinafter, “midori”).

midori operates a home-visit nursing station under the name “Hasunuma Visiting Nurse Station” that also provides care for psychiatric and pediatric patients, and is highly trusted by patients and their families.

In addition to our “Ishinkan” hospice, which specializes in end-of-life nursing and caregiving, we aim to address broader regional healthcare challenges by providing home nursing care services to patients recuperating at home, extending our support beyond facility-based care. The Company acquired this home-visit nursing station through a share acquisition; however, as the transaction does not meet the timely disclosure criteria, certain disclosure items and details have been omitted.

Outline of the Acquisition

The Company has primarily provided services within the “Ishinkan” facility, but to better address the local community’s diverse medical and nursing care needs, it is also planning to expand into home visits. Under our home-visit nursing service brand “Igokoro,” which supports home care patients, we provide the best possible nursing care, respecting and honoring our users’ wishes to spend their final days peacefully with their families in the familiarity of their own homes. Along with our “Ishinkan” hospice, which specializes in end-of-life nursing and caregiving, we aim to address broader regional healthcare challenges, extending our support beyond facility-based care through our “Igokoro” home-visit nursing service for patients recuperating at home.

Meanwhile, midori had already established a solid business foundation in its existing operational areas and had been exploring partnerships, including capital alliances, to drive further growth. Based on this alignment of policies, the Company and midori have held repeated discussions from November 2024 and, as a result, the Company acquired all of midori’s shares on February 6, 2025.
