Amvis Subsidiary Enters Management Consulting Agreement to Provide Medical Support

Amvis Holdings Corporation (Head Office: Chuo-ku, Tokyo; Representative Director: Keiichi Shibahara) is pleased to announce that its subsidiary, Ashitano Iryo, Inc. (hereinafter Ashitano Iryo), has entered into a new management consulting agreement with a medical corporation.

Ashitano Iryo entered into management consulting contracts in April with six medical institutions owned by medical corporations that took over businesses at medical corporations that filed for bankruptcy in early and mid-February this year. Ashitano Iryo is offering them management consulting services and has also begun to provide management support.

In relation to the aforementioned business transfer (hereinafter, "this case"), Amvis Holdings and Ashitano Iryo have provided debtor-in-possession financing (DIP financing, which is a type of financing given to companies that have filed for bankruptcy to allow them to continue employing staff and covering necessary daily expenses for the operation of a medical institution) for the medical corporations that have filed for bankruptcy. They have procured funds for the transferees involved in the business transfer and property and also provided working capital after the business transfers, offering complete support for the realization of this case. The flexible provision of funds, as described above, has also helped to quickly establish the company as a potential sponsor in the selection of a transferee for medical institutions in bankruptcy proceedings.

By dispatching doctors, nurses, and other medical personnel from our group and becoming deeply involved in the operations of the medical corporations we support, we suggest tailored improvement steps that address the challenges faced by these medical entities through ultra-hands-on management support. We aim to enhance profitability, strengthen the financial base, and improve operations at the medical corporations we support in a short time frame.

In this particular case, Ashitano Iryo intends to provide a hands-on approach to management support by dispatching doctors and nurses to the medical corporation it supports and also by aiding the launch of back-office functions at its head office.

Our Group will continue to engage in offering management support to a broad range of medical institutions, including general hospitals and rear-supporting hospitals, in order to achieve our mid-term goal of evolving into a comprehensive medical company.
